Angela welcomed Club member Joe Valentino, to provide a pre-Thanksgiving message. Joe did not get any formal introduction, but your editor thought it might be interesting to share some biographical details, as follows: Joe is currently a pastor at Upper Arlington Lutheran Church, having been involved in some pastoral role there since 1985. Joe also worked at the City of Upper Arlington for nearly 20 years, including as Parks and Rec Director and ultimately as Assistant City Manager. Joe is a graduate of Upper Arlington High School, and has an undergraduate degree from Ohio Dominican University and an MA in Public Administration from Ohio State.

Joe shared a message about the importance of living in the moment and giving forward. He related the life story of his grandfather, Theodore, who was an immigrant from a poor village in Calabria in Italy, and who came to the US, initially to work as a blacksmith in a coal mine in Kentucky. He earned enough ultimately to go back to Italy and marry his betrothed, Anna, and then to bring her back over to the US. Theodore also proved to have excellent drafting skills, which came to the attention of Rockwell International, which brought him and his family to Columbus, where they lived in the Hilltop neighborhood.

Joe talked about how Theodore's example of hard work and love of family, friends and country, and his faith, set an example for his children and other offspring, which now number 116, living around the US. This includes Joe and his wife Peggy's own son Joshua, without regard to the fact that Joshua is adopted and never knew Theodore. Joe encouraged all of us to consider how our own examples will affect our loved ones for many years to come, hopefully in a positive way that will make the world a better place.
