#### **ON THE WEB**



Jessica Grisez introduced Tom Schmid, President, and CEO of the Columbus Zoo. His responsibilities included the Columbus Zoo, The Wilds, Zoombezi Bay and Safari Golf Club. Tom was born in Miami and grew up in Southwest Florida. He received his undergraduate degree in Biology from Stetson University and his Masters in Biological Sciences from the University of Central Florida. Prior to accepting the position in Columbus, Tom spent 20 years at the Texas State Aquarium. Prior to that, he began his career with Sea World Orlando.

The Columbus Zoo occupies 600 acres in Delaware County and has an operating budget of over \$100 million. 200 acres is comprised of the golf course and still 100 acres remain for future expansion. Staff includes 350 full time and 1500 part time/ seasonal employees that host 2 million visitors annually. The economic impact of the zoo was recently estimated at over \$450 million. Special needs and assistance programs have been a priority. They have partnered with the Columbus Metropolitan Library to offer admission for anyone with a library card -12,000 last year.

Conservation locally, regionally, and globally is a priority for the zoo. Threatened species and rescues top these efforts. Manatees have been rescued and returned to their native environment. The zoo has assisted with an Alaskan born moose. Asian elephants have received care, as well. The zoo has facilitated a Center for Species Survival for Asian Elephants in India -a first of its kind.

Schmid praised his staff and especially their veterinarians. Additionally, their facilities are getting updates and expanding attract visitors. During cold days, the zoo may only have a few hundred visitors. Indoor observation facility enhancements look to improve this. Part of their 15-year 2040 Strategic Plan is to make the zoo a destination facility with improved transportation and possibly may include a hotel in coming years. The Wilds has a new observation deck and an RV campground will offer additional options for visitors.

#### O&A:

- The legacy of Jack Hanna is being included in zoo plans.
- Zoofari is still a fundraiser, but has been "toned down."
- Feed budget exceeds \$750,000
- · Hotel is being considered along with other lodging options.
- · Delaware County Government has been a great partner -especially Sheriff.
- 400,000-gallon manatee habitat is one of the largest in the US resulting in its success.
- The zoo has an Institutional Collection Plan to determine priority/which animals are desired
- Zoo camp is quite popular. Fills in December typically. Would like to expand.
- · Special needs adults are part of the hiring plan.
- · Pandas are a challenge due to political dealings with China.
- Elephants are quite dangerous. No longer permitting zoo employees to be in same space.
