Jeanine Hummer Introduced today's speaker Michael Stinziano, Franklin County Auditor. Mr. Stinziano shared updates about the Auditor's office initiatives, and the mass property value reappraisal that was just completed in 2023. Pursuant to the reassessment, which is required by law to be done periodically, the average value of properties in Franklin County increased approximately 40%. Property owners who do not agree with increased assessments are offered a process to have the reassessment reviewed informally prior going before the board of revisions. Mr. Stinziano reminded the group that as a State Official, he is required to follow state law in assessing and accurately determining the proper value of properties, even though reassessments can lead to significant increases.

The Auditor's Office also overseas weights and measures (for example, gasoline pumps) and dog licensing (yes, your pooch should be licensed).

Mr. Stinziano answered multiple questions from the members, and then Andy Livingston adjourned the meeting.
