**Greg Lashutka** was our speaker today. **Dick Stone** introduced Greg and reminded us of his many years of public service – including time working with Judge Richard Metcalf and Congressman Sam Devine as well as service as Columbus City Attorney and Mayor. He is now in private practice.

Greg opened his remarks by noting that he thinks we are living in the biggest time of change he has seen in his lifetime. The changes are occurring at the local, national and global levels.



The underlying theme of Greg's remarks was that communities are, to a great extent, defined by the quality of the leaders who emerge. He recounted his long term relationship with Charlie Walker who has recently passed away. Walker (an African-American attorney) was a leader in central Ohio whose greatest desire in life was to make a positive difference in the entire community. His dedication to the greater good, and similar dedication on the part of other leaders, is the reason that we live in a region that works.

People like Charlie Walker planted "green shoots" throughout the community which ultimately yielded positive results for the region.

Strong community leaders are excellent role models for the generations who follow them. He pointed out that Upper Arlington is a place where there is a large number of people committed to making and keeping the community an excellent place to live. These leaders serve as excellent role models to the generations who will follow.

The Columbus/Central Ohio region is, in reality, a "series of neighborhoods" which makes this region somewhat unusual in comparison to many other larger cities. Within that group of neighborhoods one can see distinct characteristics that reflect the nature and quality of the prevailing leadership. Overall, Lashutka believes that those communities (neighborhoods) that have strong positive leaders not only help themselves but also have a positive influence on others in the region. They serve as role models or beacons.

The greatest loss that a region can experience would be the loss of leaders who can show the way to a better future. He noted that a transition is now taking place from older, established, leaders to the next generation.

He also talked about the importance of collaborative action by various elements within the community. He cited the long term cooperative efforts of many agencies to rid Columbus neighborhoods of the scourge of the Short North Posse which was just finally dismantled after nearly 25 years of work. This speaks to the importance

of creating safe places for people to live and work. The next big area of concern which needs to be addressed aggressively and cooperatively is the opioid epidemic.

The Columbus/Central Ohio region is the only one of Ohio's seven largest metropolitan areas to have grown over the past 50 years.
