Herb Gillen introduced **Kristen Easterday** and **Casey Denny** from the Columbus Regional Airport Authority (CRAA). Kristen is Director of Communications and Public Affairs. Casey is Chief Operations Officer of CRAA.

Kristen shared background on the current terminal – noting that it was built in 1958 and has reached the end of its useful life. The building is inefficient by today's environmental and operating standards. The terminal is also situated in such a way (sandwiched between the two runways) that future growth is limited.

Planning for a new terminal is about 30% completed with the expectation that planning will be at the 60% level by January, 2024. The new terminal will be built where the existing Blue Lot is located – near the current terminal building. This will place the new terminal directly across from the recently completed rental car center. The entire project is designed around the notion of creating a good passenger experience. We saw several slides showing renderings of the new facility.

Casey noted that to upgrade the current terminal to modern standards would cost \$1 billion. The new terminal project will cost approximately \$2 billion and bring with it a more efficient facility with greater flexibility in the types of aircraft it can handle and also provide room for future growth. Funding for the project will come from three sources. The CRAA has set aside \$240 million accumulated over the years in anticipation of the new terminal. Grants from the FAA in the area of \$140 million will be secured. Airport revenue bonds will provide the remaining funding – backed by parking revenue, concessions and airline fees. Casey emphasized that the CRAA does not levy taxes.

OCTOBER

There are currently 8 million passengers per year traveling through John Glenn International. The new terminal will have a capacity of 13 million passenger – a number which addresses anticipated growth in the region.

The new terminal will have 35 or 36 gates in a single concourse. This compares to the current 30 gates spread across three concourses. The new gates will be capable of handling various sizes and types of aircraft. Currently, many gates are limited in the type of plane they can handle. This situation limits flexibility for airlines as their needs change. Two of the new gates will be designed for potential direct international flight which Casey believes will be coming in the future.

With a single concourse the new terminal will eliminate the need for three security checkpoints. Additionally, all concessionaires at the airport will be together in one area.

During Q and A Casey noted the following:

• Airline fees supporting the revenue bonds could indirectly effect airfares. Fortunately, in Columbus there is not one dominant carrier that dictates fare levels at the airport.

· Major construction should begin in 2025.

• Two gates could be configured to accommodate wide body planes and the runways are currently capable of handling such traffic.

• Most of the existing parking garage will stay and a new 5,000 car garage will be built.
