ON THE WEB



Wayne Harer introduced the speaker, Betsy Goldstein of Betsy Goldstein Consulting. Betsy has approximately 20 years of experience working in the construction industry.

Betsy's topic was "Intel on Intel" and its enormous chip-making project in Licking County. She has now presented on this topic 86 times, including to numerous local Rotary Clubs, starting with a presentation she did while working at a large architecture/construction/engineering firm, in January 2022 when the first news of the project began spreading.

Betsy said that this project will touch all corners of the state of Ohio, and will particularly impact enormously many aspects of life in central Ohio, including population, housing, economic growth, transportation and so on. The project was mentioned in each of President Biden's State of the Union addresses in 2022 and 2023.

Some specifics on the size of the project: the initial two "fabs" are a \$20 billion project, and given the passage of the Chips Act, there is a potential for a total of 8 fabs to be built, which would be a

total \$100 billion project. This dwarfs projects that were previously seen as large—for instance a \$250 million project--and were announced as triumphs of economic development. There is also the new Honda/LG Energy Solution electric vehicle battery project that is being constructed in Fayette County, with a price tag of \$4.5 billion.

Betsy shared that there will be approximately 3,000 employees in the first fab. The average salary of an Intel employee will be \$130,000. There is anticipated to be a well-above average anticipated multiplier effect of 13 jobs for each Intel employee. The fabs will not look like a stereotypical factories, but will have a sleek "campus" look, with the employees working in a "mini-city". There will be approximately 7,000 construction workers involved (compared to approx. 1,500 on the Lower.com site). This need will put great demands on the market for such labor.

Betsy described the RFI (request for information) process that Intel conducted, with the RFI sent to all 50 states. This was an outgrowth of the U.S.'s need to bring chip manufacturing back to the U.S., in part for national security reasons. Ohio shared the RFI with all 88 counties, and the only response came from the New Albany Company. The entire process, from first conversation to a deal, took about 8 months, when 36-48 months is the norm.
