Kevin Brown introduced the speaker, Daniel Gibson, the founding Headmaster of Columbus Classical Academy (CCA). Daniel is a native of Wooster. Prior to joining CCA, Daniel was a partner at the law firm of Bricker & Eckler LLP in Columbus, where he was a litigator and appellate lawyer for more than 15 years. He also served as an Associate Director at the Hudson Institute in Washington, D.C. immediately following graduation from law school. Daniel earned a Bachelor of Arts degree in Philosophy, cum laude, from Davidson College, where he was a track and field star, and he also earned a Juris Doctorate from Stanford Law School.

Some details about CCA that Daniel covered, in part derived from CCA's website, so that your editor does not have to do a lot of unproductive retyping: CCA is a private classical school in central Ohio, opening in Fall 2023, and initially serving grades K-8, adding a grade each year through grade twelve. CCA is a Hillsdale College Curriculum School. CCA does not take any government funding.

The mission of CCA is to inculcate in their students, through a genuine and rigorous classical education in the liberal arts and sciences, the knowledge and virtue upon which independent, responsible, and joyful lives are built, in the firm belief that such lives are the foundation of a free and flourishing republic. CCA's campus is located at 2000 Polaris Parkway, Columbus, OH 43240. The campus comprises roughly 60,000 square feet of space on a beautifully maintained and highly accessible 6+ acre property. This campus was made possible by the generous support of multiple donors who provided favorable financing terms as well as the extraordinary assistance of a number of professionals who gave freely of their time and expertise.

CCA describes its methodology as including the following:

Teacher led classrooms: Dan discussed how modern education emphasizes what is often called "child-centered" learning. CCA agrees that students are the object of a proper education and that the purpose of teaching is to ensure that each student masters the material and develops the personal discipline that gives rise to knowledge and virtue. This requires teachers who are attentive to the unique strengths and weaknesses of their students and who are adept at imparting knowledge to every child in their classroom, without compromising either curricular rigor or pedagogical soundness. Historically, this was not always the case in American schools.

However, as CCA sees it, too often today, "childcentered" learning makes students not only the object, but also the subject and the author of their own education, where the primary purpose of teaching is no longer to impart true knowledge and virtue but rather is to come alongside students on their own, unique path of "self-discovery" and "selfexpression." CCA believes that this approach, like the harsh indifference of some traditional schooling before it, is an abdication of the teacher's obligation to lead all of her students to a knowledge and love of what is true and good and beautiful.
